Aims & Object of the Trust:-

1. 2. To undertake all educational activities like Primary, Secondary & Higher - Secondary Schools, adult education, Engineering, Pharmacy, Dental, Homeopathic, and Physiotherapy collages, technical education, start, conduct & accordingly help necessary classes useful for the employment training and institutions.
3. To arrange the seminar/camps (Medical Camps) relating to health, blood donation and provide the ambulance and all other related facilities for the patients on Govt. bases.

4. To accept & give all type of assistance or co-operation to all other institution and undertake various effort to achieve the object of the trust.

The Trust will follow above objects in future.

A method to appoint the members on various designation:

A minimum 5 members and maximum 15 members will be appointed in the Trust. In case, with any reason/reasons if the post of member amongst permanent member would get vacated, then the other trustees shall appoint a new candidate on same empty post with majority decision and all the trustee can also appoint the President, Vice President or Treasurer.
